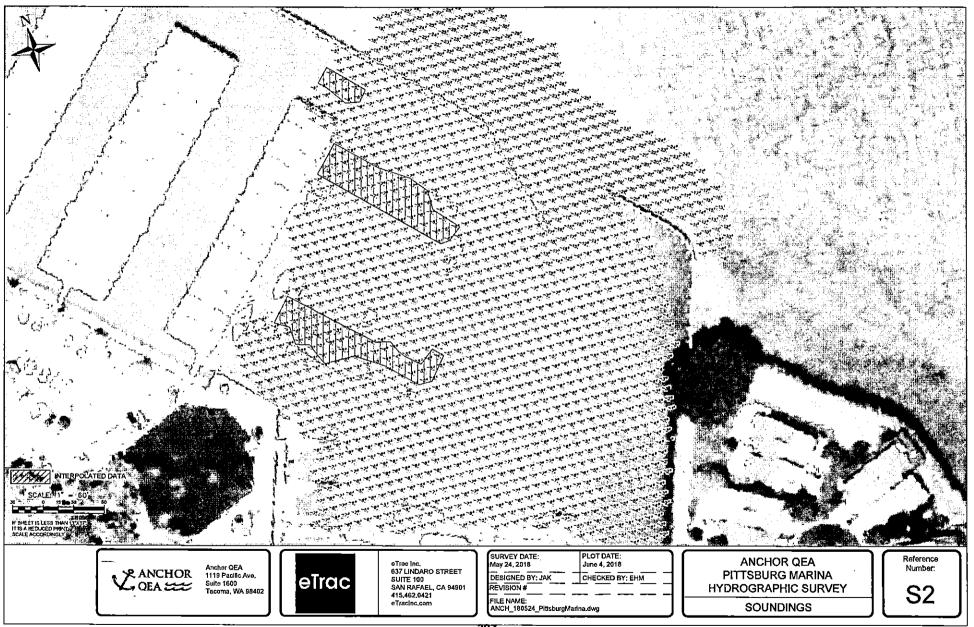

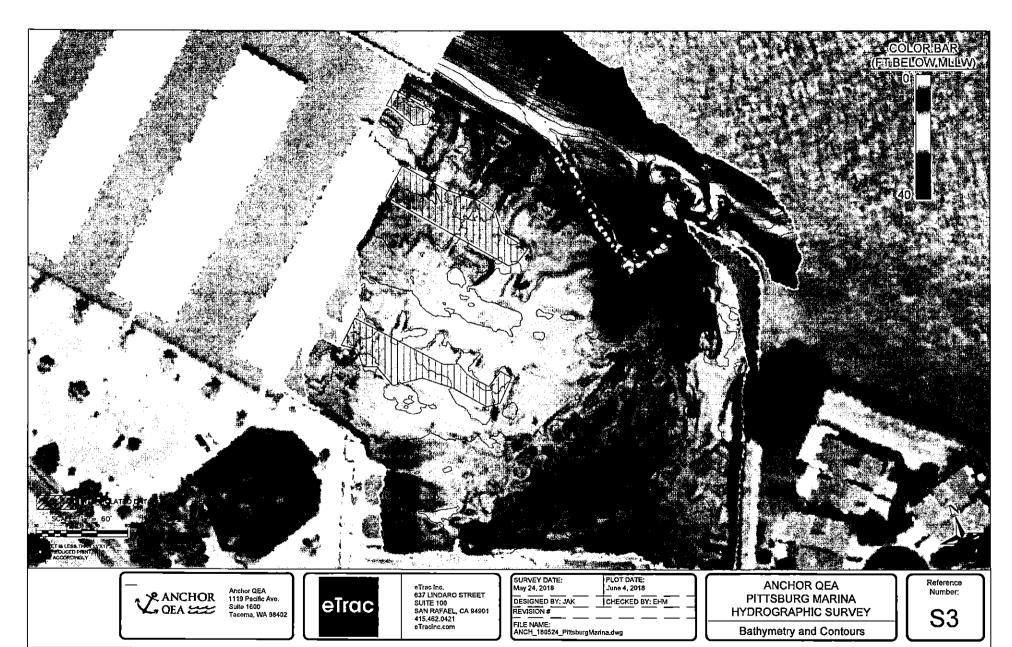

EXECUTIVE SUMMARY

The City of Pittsburg is responsible for maintenance dredging of three marina basins, storm drain outfalls in the marina vicinity, and the public launch ramps. This action will move funds in excess of the 30% enterprise fund emergency threshold to the 2019-2029 Marina Dredge Capital Improvement Project account.

FISCAL IMPACT

Transfer \$547,000 fund balance from the Marina and Waterfront fund balances to the Marina Dredge Project. After the transfer of \$250,000 from the Marina Fund Balance (550) and \$297,000 from the Waterfront Fund Balance (540), fund balance levels will remain in compliance with the Fiscal Sustainability Ordinance.

RECOMMENDATION

Staff recommends that the City Council approve the transfer of fund balances to the Marina Dredge Capital Improvement Project (5400).

BACKGROUND

A survey conducted on May 24, 2018 showed significant shoaling of Lowy Basin near the gas docks. In addition, a handful of vessels have found themselves unable to navigate the area at certain tides. It can be assumed that shoaling has also occurred at other areas for which the City of Pittsburg is responsible for dredging. The City executed a contract with Anchor QEA for preparation of 10-year dredge permit application. The permit application has been 90% completed by Anchor QEA, and the dredge project can begin upon submittal and approval by the Dredge Material Management Office (DMMO) which is expected in March, 2019.

In total, it is estimated that dredging of the three Pittsburg Marina basins, the public launch ramps, outfalls along the northern boarder of the marina, and the New York Landing Residential Channel will cost \$10.5 million over the 10-year dredge permit term. In fiscal year 2019-20, dredging of the Lowy Basin gas dock area and entryway are of high dredge priority. Costs to obtain permits and achieve this task are estimated at \$1.3 million which can be achieved in 2019 with existing project funds, Marina and Waterfront Fiscal Year 2020 operating budgets, and the requested transfer of excess fund balance to the project.

SUBCOMMITTEE FINDINGS

The Economic Development and Waterfront Subcommittee supported the use of excess Marina and Waterfront fund balances for the Marina Dredge Project at the July 24, 2018 Subcommittee Meeting.

STAFF ANALYSIS

Adoption of the resolution to transfer fund balances into the Marina Dredge Capital Improvement Project ensures budgetary stability for alleviating shoaling that has occurred in Lowy Basin as soon as possible.

WHEREAS, the City of Pittsburg is responsible for care and maintenance of the marina, and the Pittsburg Marina has experienced shoaling in some areas reducing navigability of boaters utilizing the facilities; and

WHEREAS, the City of Pittsburg as submitted applications and will receive final Dredged Material Management Office approval to dredge all areas of the Pittsburg Marina over 10-years starting with a work window of August 1 – November 30, 2019 prior to commencement of the Project; and

WHEREAS, the Engineer's Estimate for dredging Basin II of the Pittsburg Marina, the area that has experienced the most shoaling, is \$1.84 million; and

WHEREAS, the cost to dredge all of Basin II exceeds the Marina Dredge Capital Improvement Project (Dredge CIP) balance of \$716,782; and

WHEREAS, in consideration of the high expense, bids were competitively solicited for dredging of only the most impacted and urgent area of Basin II (Base Bid, Dredge Area A: Basin II entrance, guest docks, turning basin, and fuel docks); and

WHEREAS, in consideration of the high expense, bidders also submitted proposed costs for two Additive Items (Dredge Area B: All berths and channels south of the Harbor Master's Office, and Dredge Area C: All berths and channels northwest of the guest docks) that together with Area A comprise the entire Basin II; and

WHEREAS, bids were opened on August 1, 2019 and the lowest responsive responsible bidder was Pacific Dredge & Construction, LLC which provided a Base Bid (Area A only) of \$255,500; and

WHEREAS, Pacific Dredge & Construction, LLC's bid for optional Additive Items B and C is \$1,806,420 totaling \$2,061,920 including the Base Bid; and

WHEREAS, a transfer of \$1,233,218 from the Waterfront Fund and \$50,000 from the Marina Fund to the Dredge CIP will increase the Pittsburg Marina Basin II Maintenance Dredging Project (Project) budget to \$2,000,000, allowing the City to afford the base bid and potentially negotiate one or more additive bid items while maintaining the Waterfront Fund balance above the required fund balance reserve of 30%; and

WHEREAS, staff recommends City Council authorize the transfer of Waterfront and Marina Funds to the Dredge CIP, and

WHEREAS, staff recommends authorizing the City Manager to award a Construction Contract not to exceed \$2 million to Pacific Dredge & Construction, LLC on behalf of the City, and

WHEREAS, staff also recommends that a construction contingency of \$200,000, approximately 10% of the not to exceed contract amount be authorized for the Project; and

WHEREAS, staff further recommends that the City Engineer be authorized to approve contract change orders for this Project in a total amount not to exceed 50% of the contingency and the City Manager be authorized to approve change orders for this Project in a total amount not to exceed 100% of the contingency amount; and

WHEREAS, the Economic Development and Waterfront Subcommittee supported the utilization of Waterfront Fund balance to fund the Dredge CIP during the July 24, 2018 Subcommittee meeting and supported the Project timeline at the June 25, 2019 Subcommittee meeting.

EXECUTIVE SUMMARY

The City of Pittsburg is responsible for maintenance dredging of three marina basins, storm drain outfalls in the marina vicinity, and the public launch ramps. This action will move funds in excess of the 30% Enterprise Fund required reserves to the 2019-2029 Marina Dredge Capital Improvement Project (Dredge CIP). With this movement of funds, the Dredge CIP balance is enough to award the Pittsburg Marina Basin II maintenance Dredging Project (Project) contract to the lowest responsive responsible bidder, Pacific Dredge & Construction, LLC.

FISCAL IMPACT

As of July 1, 2019 the Dredge CIP was funded with \$432,000 from the Waterfront Fund and \$541,208 from the Marina Fund for a total budget of \$973,208 (Project 5400). After expenditures and encumbrances for permitting, surveying, and consulting costs, a balance of \$716,782 is available for expenditure from the Dredge CIP.

The lowest responsive responsible Base Bid submitted by Pacific Dredge & Construction, LLC is \$255,500. Pacific Dredge & Construction, LLC's bid for optional additive items is \$1,806,420. Together the Base Bid and optional Additive Items total \$2,061,920.

As of July 1, 2019 the Waterfront Fund has a fund balance of \$1,403,790 in excess of its 30% required reserves, and the Marina Fund has a fund balance of \$411,302 in excess of its 30% required reserves. Transfers of \$1,233,218 from the Waterfront Fund (540) and \$50,000 from the Marina Fund (550) will bring the Dredge CIP balance to \$2 million while maintaining Waterfront and Marina Funds compliance with the Fiscal Sustainability Ordinance.

RECOMMENDATION

Staff recommends the City Council adoption of the attached Resolution authorizing the transfer of Waterfront and Marina Funds to the Dredge CIP, and authorizing the City Manager to award a Construction Contract not to exceed \$2 million on behalf of the City, and negotiate Additive Items.

Staff also recommends that a construction contingency of \$200,000, approximately 10% of the not to exceed contract amount, be authorized for the Project. Staff further recommends that the City Engineer be authorized to approve contract change orders for this Project in a total amount not to exceed 50% of the contingency and the City Manager be authorized to approve change orders for this Project in a total amount not to exceed 100% of the contingency amount.

BACKGROUND

The City of Pittsburg is responsible for maintenance dredging of three marina basins, storm drain outfalls in the marina vicinity, and the public launch ramps. The City has not conducted a maintenance dredge project since 2012. The City has submitted all applications and will receive final Dredged Material Management Office approval to dredge all areas of the Pittsburg Marina over 10-years prior to the commencement of the Project. In total, it is estimated that dredging of the three Pittsburg Marina basins, the public launch ramps, and the New York Landing Residential Channel will cost \$10.5 million over the 10-year dredge permit term.

A survey conducted on May 24, 2018 showed significant shoaling of Basin II near the fuel docks. In addition, a handful of vessels have found themselves unable to navigate the area at certain tides. It can be assumed that shoaling has also occurred in other basins and areas for which the City of Pittsburg is responsible for dredging. In the near term, dredging of Basin II fuel dock area and entryway are of highest dredge priority.

SUBCOMMITTEE FINDINGS

The Economic Development and Waterfront Subcommittee supported the use of excess Marina and Waterfront Fund balances for the Marina Dredge Project at the July 24, 2018 Subcommittee Meeting and supported the dredge project timeline at the June 25, 2019 Subcommittee Meeting.

STAFF ANALYSIS

The Engineer's Estimate for dredging Basin II is \$1.84 million. In consideration of the high expense of the Project and the remaining Dredge CIP balance, staff is requesting transfers of Waterfront and Marina Fund balance to the CIP Project to fund the Dredge CIP up to \$2,000,000. City staff and project management consultant Anchor QEA also strategically re-scoped the Project into three dredge areas based on need as follows:

- A. Basin II entrance, guest docks (Docks E and F), turning basin, and fuel docks
- B. All berths and channels south of the Harbor Master's Office (Docks G, H, I, J, and K)
- C. All berths and channels northwest of the guest docks (Sheds A, B, C, and D).

Parsing the area as such allowed the City to receive competitive bids for Base Bid Items (Dredge Area A above) that are fiscally manageable under the Dredge CIP balance. Pricing received for Additive Items B and C were not considered in the determination of the lowest responsive responsible bidder. This consideration of Additive Items B and C may be negotiated after formal contractor selection is awarded based on remaining Dredge CIP balance and time remaining in the permitted work window (August 1 – November 30, 2019).

On Thursday, July 11, 2019 and Thursday, July 18, 2019, the construction documents for the Project were advertised. A Mandatory Pre-bid Meeting was held on Wednesday, July 24, 2019 at 10:00AM. Bids were opened on Thursday, August 1, 2019 at 2:00 PM, at which time two (2) bids were received and read aloud. Staff has reviewed the bids and has determined that the budget, with movement of \$1,233,218 from the Waterfront Fund and \$50,000 from the Marina Fund, is enough to award the contract for Dredge Areas A, B and C. In addition, it was determined that the bid submitted by Pacific Dredge & Construction, LLC is a responsive bid and represents the lowest bid received for the Project.

Staff recommends adoption of the Resolution to transfer fund balances into the Project, authorize the City Manager to negotiate pricing for Additive Items B and C, and execute a Construction Contract with the lowest responsive responsible bidder to ensure the City's ability to alleviate significant shoaling that has occurred in Basin II during the upcoming 2019 work window.
