RE: **Agenda Item 52: Support for Proposed Amendment of Existing Lease with PG&E**

Dear President Yee, Members Kounalakis and Bosler:

On behalf of the over 21,000 members of International Brotherhood of Electrical Workers Local Union 1245 working in California, I write to urge you to adopt the Staff recommendation to change the submittal date for Pacific Gas and Electric Company a plan for restoration of lease premises to August 26, 2023.

The IBEW represents roughly 12,500 members working for Pacific Gas and Electric Company, including over 600 working at Diablo Canyon Power Plant. Some will be engaged in important work to decommission Diablo Canyon. But at present they must maintain focus on keeping the plant running safely.

This lease amendment will allow PG&E to continue working with your staff and the staffs of the Coastal Commission and County of San Luis Obispo to develop fully plans needed for the decommissioning of Diablo Canyon and ensure the best possible site restoration. Given that the plant is licensed to operate for another four and a half years, any restoration plans formulated this year would likely be too general to be helpful. By requiring PG&E to provide their decommissioning plan in August 2023, it ensures that your staff will be able to adopt a complete and detailed restoration approach when Diablo Canyon is much closer to its retirement date.

Please approve the amendment to Lease No. PRC 9347.1 with PG&E. This will help our members and the general public.

Port San Luis Harbor District is supportive of the staff recommendation to amend Lease No. PRC9347.1, Section 2, Special Provisions, paragraph 5(iii), to change the submittal date for a proposed plan for the restoration of the Lease Premises from August 26, 2020 to August 26, 2023. Especially in light of State Land staff's belief that the proposed lease amendment will not result in significant changes in the use of, or impacts to, Public Trust resources; does not substantially interfere with Public Trust needs and values at this location, at this time, and for the foreseeable term of the lease, and is in the best interests of the State

In August 2018, the Board of Commissioners for the Port San Luis Harbor District, adjacent property owner to the Diablo Nuclear Power Plant, indicated their interest in some of the Diablo Canyon assets specifically those that relate to Harbor District Operations.

By review of the staff report and proposed motion, this requested technical change to the lease appears to be beneficial in the overall decommissioning and repurposing process.
