# Staff Report 47

Revision of Rent

### LESSEE:

San Diego Gas & Electric Company

## PROPOSED ACTION:

#### AREA, LAND TYPE, AND LOCATION

Sovereign land in and adjacent to the San Dieguito River, Del Mar, San Diego County.

#### **AUTHORIZED USE:**

Retention, use, and maintenance of a 4-inch-diameter natural gas pipeline attached to the Camino Del Mar Bridge.

#### TERM:

25 years, beginning October 1, 2010.

#### CONSIDERATION:

This lease provides that the Commission may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease and recommends that rent be revised from \$450 per year to \$503 per year, effective October 1, 2020.

# **OTHER PERTINENT INFORMATION:**

- Approval or denial of the revision of rent is a discretionary action by the Commission. Each time the Commission approves or rejects a revision of rent, it exercises legislatively delegated authority and responsibility as trustee of the State's Public Lands as authorized by law. Upon expiration or prior termination of the lease, the Lessee has no right to a new lease or to renewal of any previous lease.
- 2. On October 29, 2004, the Commission authorized a General Lease Right-of-Way Use to San Diego Gas & Electric Company for retention, use, and maintenance of a

4-inch-diameter natural gas pipeline (<u>Item 41, October 29, 2010</u>). The lease will expire on September 30, 2035. The rent associated with this lease was last revised in 2015 (<u>Item 71, June 29, 2015</u>).

- 3. Staff has requested updated inspection reports from the Lessee. Staff has not received the results of the inspection but will follow up with the Lessee.
- 4. The action is consistent with Strategy 2.2 of the Commission's Strategic Plan to ensure timely receipt of revenues and royalties from the use and development of State lands and minerals.
- 5. Approving the revision of rent is not a project as defined by the California Environmental Quality Act because it is an administrative action that will not result in direct or indirect physical changes in the environment.

Authority: Public Resources Code section 21065 and California Code of Regulations, title 14, section 15378, subdivision (b)(5).


A. Site and Location Map
