# RECORD OF ACTION TAKEN BY THE CALIFORNIA STATE LANDS COMMISSION:

Chair Eleni Kounalakis called the meeting of the California State Lands Commission to order at 1:01 P.M. via Zoom webcast; also present were Commissioner Betty Yee and Commissioner Alternate Gayle Miller.

Confirmation of the Minutes of the February 23, 2021 meeting was approved as presented by a vote of 3-0 (Kounalakis–Yes; Yee–Yes; Miller–Yes).

#### **EXECUTIVE OFFICER'S REPORT:**

Executive Officer Jennifer Lucchesi updated the Commission on the following items:

• Rincon Well Abandonment and Decommissioning Project: We continue to make great progress on this Project. As I reported at our last meeting, 74 of the 75 wells associated with this operation have been abandoned. The last well, an onshore injection well, is scheduled to be abandoned by the end of this month. Removal and disposal of other production-related equipment and structures are in progress.

The Commission's contractor, DrilTek, is preparing the onshore and offshore areas for caretaker status. This work will prepare the site for the hiatus between the end of well and surface abandonment and the final island and onshore decommissioning phase.

Project expenses remain ten percent below estimates and the well and surface abandonment and caretaker status preparation work is on course to be completed before June 30<sup>th</sup> of this year.

The feasibility study, the first part of phase two of the Project is next. The study will include a geophysical survey, biological assessment, environmental analysis, coastal engineering study, socio-economic analysis, soil and water assessments, and engineering assessment. The feasibility study is anticipated to be completed within six months, after which the CEQA analysis will begin. The feasibility study and CEQA analysis will include extensive public and stakeholder outreach. Commission staff started that outreach on April 7th, when we hosted a town hall event to update the community and stakeholders about the Project status and next steps. The event was well received and attended by members of the Mussel Shoals community in Ventura, government agencies, local non-governmental organizations, and other stakeholders.

 Platform Holly Abandonment Project: Platform Holly and the plugging and abandonment work remains suspended due to the COVID-19 pandemic restrictions and space limitations on the platform that make physical distancing impractical. Staff continues to maintain and monitor the platform and onshore facilities to ensure public health and safety. Staff and ExxonMobil are monitoring the COVID-19 situation and are preparing for plug and abandonment work of the 30 wells on the platform to hopefully resume in late summer depending on the State's mandates.

In March, the Commission hosted a virtual town hall to update the community about the project status and the upcoming CEQA process to remove the Last remaining oil piers in the shore at Haskell's Beach. The event was well received and attended by numerous stakeholder groups, government agencies, local non-governmental organizations, and members of the public. Staff expects to issue a Notice of Preparation for the oil pier removal project soon. The Commission will be the CEQA Lead Agency and applicant for the project. We are working very closely with the City of Goleta and the Coastal Commission on this work. Public outreach and input will be a foundational part of the CEQA process.

Item 46 – was approved as presented by a vote of 3-0 (Kounalakis–Yes; Yee–Yes; Miller–Yes)

**Item 47:** A staff presentation was made to the Commission to consider extending the sunset date of the limited delegation of authority to the Executive Officer for the COVID-19 Rent and Application Expense Deferral Program previously authorized by the Commission.

Item 47 – was approved as presented by a vote of 3-0 (Kounalakis–Yes; Yee–Yes; Miller–Yes)
