LESSEE:

U.S. Borax Inc.

PROPOSED ACTION:

Amendment to increase the performance bond, reduce the lease area by 124.26 acres, and to acknowledge a partial Quitclaim Deed, for Mineral Extraction Lease No. 5464

AREA, LAND TYPE, AND LOCATION:

Approximately 15,543 acres of State sovereign land, Townships 17 South and 18 South, Range 37 East, Mount Diablo Baseline & Meridian, located on the dry lakebed of Owens Lake. This sovereign land is located east of U.S. Highway 395, approximately 10 miles south of the town of Lone Pine, Inyo County.

AUTHORIZED USE:

Extraction of industrial minerals, a sodium carbonate mineral (trona), and any other mineral deposits except oil, gas, other hydrocarbons, and geothermal resources.

TERM:

10 years, effective August 1, 2018.

CONSIDERATION:

- **State's royalty**: 10 percent for unprocessed trona and 7 percent for processed trona.
- **Annual rent**: \$2.50 per acre or \$38,858.
- **Minimum annual royalty**: \$120,000. If the cumulative amount of quarterly royalties paid during the prior lease year exceeds \$120,000, there is no minimum annual royalty owed.

PROPOSED AMENDMENT:

- **New lease acreage**: Approximately 15,419 acres, following Lessee's partial quitclaim of 124.26 acres.
 - Replace Exhibit A, Land Description, in the Lease with a new Exhibit A, Land Description, and Exhibit B, Location Map (See Exhibits A and B, attached).
- **Annual rent:** \$2.50 per acre which equates to \$38,547.50, changing the Annual rent due to the reduced acreage.
- **Performance Bond**: Lessee will increase their financial security to \$160,000 from \$60,000 to guarantee performance of the lease terms and conditions.

BACKGROUND

In 1978, Lease 5464, a mineral extraction lease, was originally issued to Lake Minerals Corporation, for an initial term of 20 years (Item 26, March 30, 1978). On January 24, 1980, the Commission approved the assignment of mineral extraction Leases 4754, 4996, and 2967 by Morrison & Weatherly Chemical Products to Lake Minerals Corporation (Item 31, January 24, 1980). These four leases were consolidated into Lease 5464 (Lease) in June 1980, increasing the leased acreage, minimum annual royalty, and performance bond (Item 18, June 26, 1980). In 1998, Lake Minerals Corporation assigned the Lease to the Lessee and the Lease was renewed for a 10-year period ending July 31, 2008 (Item 115, June 19, 1998). In October 2004, the Commission authorized amendment of the Lease to increase the bond and provide for four renewal periods of 10 years each (Item 52, October 6, 2004).

On December 17, 2009, the Commission approved the first of the 10-year renewals, retroactive from August 1, 2008, through July 31, 2018, due to holdover and an amendment, which reduced the leased acreage from 16,120 to 15,700 acres (Item 35, December 17, 2009). The Lease amendment also resulted in a modification of the royalty. In 2015, the acreage was reduced to 15,543 acres to allow the City of Los Angeles Department of Water and Power (LADWP) to use a portion of the previously leased lands for dust abatement (Item 72, August 19, 2015). On June 21, 2018, the Commission authorized another 10-year Lease renewal to the Lessee, which will expire on July 31, 2028 (Item 80, June 21, 2018).

STAFF ANALYSIS AND RECOMMENDATION:

AUTHORITY:

Public Resources Code sections 6005, 6216, 6301, 6804, 6890, and 6898; California Code of Regulations, title 2, section 2200 et seq.

PUBLIC TRUST AND STATE'S BEST INTEREST:

Public Resources Code section 6804.1 provides that "a lessee may at any time make and file with the commission a written quitclaim or relinquishment of all rights under any lease or of any portion thereof comprising a 10-acre parcel or multiple thereof in a compact form, or of any separate or distinct zone or geological horizon or portion thereof underlying such 10-acre parcel or multiple thereof," and that "such quitclaim or relinquishment shall be effective as of the date of its filing." The statute further provides that a lessee shall be released from all obligations thereafter accruing with respect to such quitclaimed lands, so long as the lessee has fulfilled all obligations of the lease, including payment of rent and royalties, and abandonment of the lease facilities.

On August 26, 2022, the Commission received Lessee's partial quitclaim deed dated July 19, 2022 (Exhibit C, attached) pursuant to Public Resources Code section 6804.1. This partial quitclaim deed quitclaims to the State all the Lessee's right, title, and interest in 124.26 acres of the leased lands.

This partial quitclaim is necessary to facilitate the construction of two new Dust Control Areas (DCA), T1A-4 Addition and T10-3a Addition, by LADWP. The two new DCAs are surrounded by the existing Lake Minerals Road. Design of the new DCAs include improvements to Lake Minerals Road. As part of LADWP's proposed project, new perimeter berm/roads will be constructed to provide a complete, drivable loop around each DCA. An amendment to the City's lease for dust control measures on Owens Lake has been considered and approved by the Commission (Item 26, August 23, 2022).

Staff has reviewed the files, and there are no outstanding defaults or breaches of the lease pending the partial quitclaim. The Lessee has complied with all applicable laws and Lease provisions and has paid all rentals and royalty under Mineral Extraction Lease No. 5464.

Section 3, Paragraph 4 of Lease No. 5464, requires the Lessee to pursue reclamation of the leased lands in accordance with its approved Surface Mining Reclamation Plan and reclaim the leased lands to the satisfaction of the Commission and Inyo County. The Surface Mining and Reclamation Act of 1975 (SMARA, Public

Resources Code, Sections 2710-2796) provides a comprehensive surface mining and reclamation policy with the regulation of surface mining operations to assure that adverse environmental impacts are minimized, and mined lands are reclaimed to a usable condition.

On July 8, 2022, staff sent a letter to the Lessee, confirming Lessee's assertion they have not mined, altered, or otherwise disturbed the quitclaimed area. The only remaining indication of historical mining operations on the quitclaimed area is remnant trona piles that will be leveled by LADWP during construction of their new dust control measures. Therefore, the Lessee will be released from all obligations with respect to the quitclaimed area.

CONCLUSION:

For all the reasons stated above, staff finds the proposed amendment and partial quitclaim will not substantially interfere with Public Trust needs and values at this location, at this time, and for the foreseeable term of the lease; is consistent with the common law Public Trust Doctrine; and is in the best interests of the State. Staff recommends acknowledgment of the partial quitclaim deed effective on July 19, 2022, the filing date, and recommends approval of the lease amendment.

OTHER PERTINENT INFORMATION:

- 1. Acceptance of the partial quitclaim deed and amendment of the Lease is not a project as defined by the California Environmental Quality Act (CEQA) because it is an administrative action that will not result in direct or indirect physical changes in the environment.
 - Authority: Public Resources Code section 21065 and California Code of Regulations, title 14, section 15378, subdivision (b)(5).
- 2. This action is consistent with the "Meeting Evolving Public Trust Needs" and the "Leading Climate Activism" Strategic Focus Areas of the Commission's 2021-2025 Strategic Plan.
- 3. No default payments currently exist on the lease, and the Lessee has complied with all applicable laws and lease provisions.

RECOMMENDED ACTION:

It is recommended that the Commission:

PUBLIC TRUST AND STATE'S BEST INTERESTS:

Find that the acknowledgment of a partial quitclaim deed and the amendment will not substantially interfere with the Public Trust needs and values at this time; is consistent with the Public Trust Doctrine; and is in the best interests of the State.

AUTHORIZATION:

- 1. Acknowledge receipt of a partial Quitclaim Deed effective on July 19, 2022, the filing date, for Mineral Extraction Lease No. 5464, wherein the Lessee quitclaims to the State all of its rights, title, and interest in 124.26 acres of the leased lands described in the attached Exhibit C.
- 2. Authorize the Amendment of State Mineral Extraction Lease No. 5464 to U.S. Borax, Inc., effective August 23, 2022, through July 31, 2028, pursuant to the terms substantiated in the Amendment form, attached hereto as Exhibit D. All other terms and conditions of the Lease shall remain in full force and effect without amendment.
- 3. Release U.S. Borax Inc. from any obligations accruing after July 19, 2022, the filing date of the partial quitclaim deed, with respect to the 124.26 acres quitclaimed and removed from Mineral Extraction Lease No. 5464.



AMENDMENT OF MINERAL EXTRACTION LEASE NO. 5464, OWENS LAKE, INYO COUNTY, CALIFORNIA

This amendment is entered into by and between the State of California, through the California State Lands Commission as Lessor ("State"), and U.S. Borax, Inc., a corporation organized and existing under the laws of the State of Delaware, as Lessee (the "Company").

RECITALS

WHEREAS, on August 1, 1978, the State and Lake Minerals Corporation entered into Mineral Extraction Lease PRC 5464.1 (the "Lease"), covering 6,440 acres, for an initial term of 20 years, with an option to renew for three successive periods of ten (10) years each; and

WHEREAS, effective August 1, 1980, the Lease was amended, increasing the leased lands to 16,120 acres, increasing the performance bond from \$10,000 to \$30,000, and increasing the minimum annual royalty to \$120,000; and

WHEREAS, effective October 7, 1993, the Lease was amended, removing 3,480 acres from the leased lands, but adding 3,480 new acres to maintain the total leased acreage of 16,120 acres; and

WHERAS, effective August 1, 1998, the Lease was renewed for a period of 10 years, beginning August 1, 1998, and ending July 31, 2008; and

WHEREAS, effective May 1, 1999, the Lease was assigned by Lake Minerals Corporation to U.S. Borax Inc.; and

WHEREAS, effective November 1, 2004, the Lease was amended, providing the option to renew the Lease for four successive 10-year terms following the July 31, 2008 expiration, increasing the bond to \$60,000, and limiting permitted activities under the Lease to those set forth in Conditional Use Permit No. 2002-13/U.S. Borax and Reclamation Plan No. 2002-1/U.S. Borax that were approved by the Inyo County Planning Commission on April 28, 2004 (allowing construction of a water well, wash plant, and drying/calcining facility); and

WHEREAS, effective August 1, 2008, the Lease was renewed for a period of 10 years, beginning August 1, 2008, and ending July 31, 2018, and amended to revise the royalty calculation, require insurance in the amount of \$2,000,000 per occurrence, require reclamation in accordance with the Surface Mining and

Reclamation Act and Lessee's Surface Mining and Reclamation Plan, and replace the Land Description and revise the acreage under lease to 15,700 acres, so that the City of Los Angeles Department of Water and Power (LADWP) could use a portion of the land previously under lease for dust abatement; and

WHEREAS, effective June 22, 2015, the Lessee quitclaimed to the State approximately 157 acres of the leased lands, reducing the acreage under Lease to 15,543 acres; and

WHEREAS, effective August 1, 2018, the Lease was renewed for a period of 10 years, beginning August 1, 2018, and ending July 31, 2028; and

WHEREAS, Lessee wishes to quitclaim a portion of the leased land to the State, and thereby reduce the acreage under Lease from 15,543 acres to 15,418.74 or 15,419 acres; and

WHEREAS, the State wishes to increase the performance bond requirement from \$60,000, as agreed to in the 2004 amendment, to \$160,000; and

WHEREAS, it is the desire of the State and the Lessee to amend the Lease as follows.

AGREEMENT

The Parties hereto agree as follows:

- Exhibit A, Land Description, of the Lease, as amended effective August 1, 2008, and June 22, 2015, is deleted in its entirety and replaced with the new Exhibit A, Land Description, attached hereto. Such Land Description includes approximately 15,419 acres.
- Section 1, Paragraph 4, of the Lease, as previously amended in 2004, is further amended to read: "The performance bond required pursuant to paragraph 19 of Section 5 is to be in the amount of \$160,000. Lessee shall furnish this bond by December 1, 2022."
- 3. All other terms and conditions of the Lease shall remain in full force and effect.
