RECORD OF ACTION TAKEN BY THE CALIFORNIA STATE LANDS COMMISSION:

Chair Betty Yee called the meeting of the California State Lands Commission to order at 10:01 a.m. at the Warren-Alquist State Energy Building, Rosenfeld Hearing Room, First Floor, 1516 Ninth Street, Sacramento, California 95814 via in person and Zoom webcast; also present was Commissioner Eleni Kounalakis.

Confirmation of the Minutes of the October 25, 2022, meeting was approved as presented by a vote of 2-0 (Yee–Yes; Kounalakis–Yes; Miller–not present).

EXECUTIVE OFFICER'S REPORT:

Executive Officer Jennifer Lucchesi updated the Commission on the following items:

Award – Association of the California State Employees with Disabilities

The Commission received an award from the Association of the California State Employees with Disabilities. The Commission was awarded with the 2022 award for medium State employer, were recognized for improving employment opportunities for individuals with disabilities.

Crockett Update

The Executive Officer provided an update on efforts to clean up the Crockett waterfront along the Carquinez Strait.

In the 1990s and 2000s, the Crockett waterfront fell into financial difficulties and the lessee, Dowrelio's Boat Harbor, stopped making lease payments. The marina also fell into disrepair. In 2011, the Commission found that the lessee was in trespass and unlawfully occupying State land, and authorized the staff and the Attorney General's office to take action against the former lessee to collect back rent and address the ongoing trespass.

The Commission agreed to consider a new lease application pursuant to a settlement agreement. In 2014, the Commission authorized a new lease to Crockett Marine Services. And Crockett Marine Services at the time agreed to

take the necessary steps to remove and restore the improvements within the lease area.

Crockett Marine Services initially took steps to clean up the lease premises. However, in 2016, the Commission received information that the condition of the facilities continued to be in disrepair. In 2018, the Commission authorized the termination of that lease, which then prompted staff to move on to seeking funding to clean up the waterfront.

Since 2019, staff has worked closely with the local community to conduct numerous cleanups at the site. In 2020, a fire destroyed the boat repair structure, which prompted staff to take immediate action to address the hazardous removal activities and ensure cleanup was done properly.

Staff conducted outreach on the potential reuse of the site and with various groups, including the Contra Costa Resource Conservation District. The Commission ended up supporting their application to the Natural Resources Agency Urban Greening Grant Program for the site.

Access across the railroad tracks continues to be an issue. During this process, staff concluded that the retention of the restaurant structure was not conducive to reuse at the site, so staff proceeded to remove the restaurant down to the concrete pad in December of last year. In June of this year, staff entered into a contract to remove the existing vessels, pilings, and the army pier at the site. To date, contractors have removed over 100 tons of material and waste from the site. Additional work includes the removal of the concrete pad at the former restaurant site.

The cleanup of the Crockett waterfront is a significant achievement and was a true team effort. Executive Officer Lucchesi recognized staff that have helped to lead this effort, including Nick Lavoie, who is no longer with the Commission. Staff Attorney Andrew Kershen has been indispensable over the past couple of years helping us not only here at Crockett, but with all our abandoned vessels and enforcement cleanup activities. But no one has been more important to this effort than Vicki Caldwell, who has been at the center of this Crockett waterfront cleanup from the beginning. And through building relationships with the local community, with regulatory agencies, she has been able to navigate contracts, organize public meetings, move through the entitlement process as efficiently as possible, and work with us to secure funding for cleanup of this site. She even spent her personal time participating in community cleanup days at this site.

Platform Holly and Piers 421 Decommissioning (South Ellwood)

Earlier this week, the Commission's contractor started physically taking down the caissons around the Piers 421 wells in the shorezone at Goleta. This is an incredible milestone in just removing that entire infrastructure that blocks public access and really is symbolic of the Commission's transition from fossil fuel production offshore. We've started removing the actual caisson structures, which are the walls around the wells. Next, we will remove the piers. By February of next year, you should see no more remnants of that offshore infrastructure for oil production.

Mary Murray, the Equal Employment Opportunity Officer for the Commission, has been with the Commission for over 22 years, and has worked for the State for over 31 years.

Chris Beckwith, Division Chief of the Marine Environmental Protection Division, which is headquartered in Long Beach. He has also been working for the State for over 30 years in various positions both at the commission and at Fish and Wildlife's Office of Spill Prevention and Response Office.

Item 70: A staff presentation was made to the Commission to consider an application for a General Lease – Protective Structure Use, compensation for unauthorized occupation, and authorization to take all action necessary, including litigation, to remove unauthorized improvements, of sovereign tide and submerged land located in the Pacific Ocean, adjacent to Assessor Parcel Number 005-600-018, near Carpinteria, Santa Barbara County; for existing rock revetment.

Amended motion:

The Commission authorizes staff's recommendation as detailed in the staff report before you with the modification to the paragraph in the lease addressing unauthorized occupation of State lands. And that is to be calculated between December 9, 2017 and May 15, 2020. In addition, changes to the paragraph dealing with bond and liability protection, that the bond amount of \$860,000 can be built up in equal installments over time over the term of the 10-years lease to either \$860,000 or to the amount that the consultant that's hired by the homeowner's association determines for removal cost.
