**NOTICE OF PUBLIC REVIEW AND INTENT TO ADOPT A  
MITIGATED NEGATIVE DECLARATION**

(State CEQA Guidelines, sections 15072 and 15073)

A Mitigated Negative Declaration (MND) has been prepared by the California State Lands Commission (CSLC), as lead agency under the California Environmental Quality Act (CEQA) (Pub. Resources Code, § 21000 et seq.) in response to an application submitted by the Pacific Gas and Electric Company (PG&E) for the PG&E Gas Line 021G Replacement Project (L 021G/R-708)<sup>1</sup> Across the Petaluma River (Project). The MND was prepared in compliance with the requirements of CEQA, the State CEQA Guidelines (Cal. Code Regs., tit. 14, § 15000 et seq.), and CSLC regulations (Cal. Code Regs., tit. 2, § 2901 et seq.).

**Project Title:** PG&E Gas Line 021G Replacement Project (L 021G/R-708)  
Across the Petaluma River

**Project Location:** Southeastern Petaluma extending from 1400 Cader Lane (Shollenberger Park) in the City of Petaluma, crossing the Petaluma River, to 3393 Petaluma Boulevard South in unincorporated Sonoma County.

**Project Description:** The Project would consist of the replacement of the existing 021G natural gas pipeline. Approximately 1,852 feet of 16-inch-diameter steel replacement pipeline (R-708) would be installed (492 feet in upland locations using open trench and backfill methods and 1,360 feet under the Petaluma River by the horizontal directional drilling methods) adjacent to the existing pipeline. Two approximately 368-foot parallel sections of the existing 12-inch-diameter steel pipeline (021G) and driplines would then be removed from beneath the Petaluma River, and 1,278 feet of the existing 16-inch-diameter natural gas pipeline and 2,690 feet of 0.75-inch dripline (in upland locations) would be retired in place.
