# CHAPTER 493

An act to establish the line of ordinary high tide in Avalor Bay, in Los Angeles County, California, in conformity with a certain decree of the Superior Court of the State of California, in and for the County of Los Angeles, establishing said line of ordinary high tide.

WHEREAS, The State of California has heretofore g anted to the City of Avalon, a municipal corporation in Los Angeles County, California, and to its successors, all the right, title and interest of the State of California. held by said State, by virtue of its sovereignty, in and to certain of the tidelands and submerged lands bordering in and upon Avalon Bay, below the line of ordinary high tide of the Pacific Ocean, by act of Legislature approved by the Governor May 2, 1943, filed with the Secretary of State May 2, 1943, and in effect August 4, 1943, upon the uses, trusts and conditions set forth in said acts; and

WHEREAS. At the time of said grant the line of ordinary high tide of the Pacific Ocean. in said Avalon Bay, had not been established; and

WHEREAS, The line of ordinary high tide of the Pacific Ocean in said Avalon Bay has not been established insofar as the uplands hereinafter described are concerned; and

WHEREAS. It is to the general public interest that such line of ordinary high tide in said bay be established by act of the Legislature in conformity with that certain decree of the superior court of the State of California, in and for the County of Los Angeles, being Decree No. 555038; now, therefore,

In effect October 1. 1949 [Approved by Governor June 1, 1949 Filed with Secretary of State June 1, 1949.]

#### The people of the State of California do enact as follows:

Establishment of ordinary bigh tide line in Avalon Bay

SECTION 1. The line of ordinary high tide of the Pacific Ocean in Avalon Bay, insofar as the uplands hereinafter described are concerned, being those certain uplands situate in the City of Avalon, County of Los Angeles, State of California, and particularly described as follows:

# PARCEL NO. 1

A parcel of land in the City of Avalon, Island of Santa Catalina, County of Los Angeles, State of California, described as follows:

SEC. 2. All lands lying between said ordinary high tide Accretions line heretofore described and the uplands heretofore described, constitute natural accretion to said uplands and belong to and are a part of said uplands.
