**NOTICE OF PUBLIC REVIEW AND INTENT TO ADOPT A  
MITIGATED NEGATIVE DECLARATION**

(State CEQA Guidelines, sections 15072 and 15073)

A Mitigated Negative Declaration (MND) has been prepared by the California State Lands Commission (CSLC), as lead agency under the California Environmental Quality Act (CEQA) (Pub. Resources Code, § 21000 et seq.) in response to an application submitted by the Pacific Gas and Electric Company (PG&E) for the Pacific Gas and Electric Company L-021A Napa River Pipeline Crossing Replacement Project under the Napa River (Project). The MND was prepared in compliance with the requirements of CEQA, the State CEQA Guidelines (Cal. Code Regs., tit. 14, § 15000 et seq.), and CSLC regulations (Cal. Code Regs., tit. 2, § 2901 et seq.).

**Project Title:** Pacific Gas and Electric Company L-021A Napa River Pipeline Crossing Replacement Project

**Project Location:** The Project area begins near Suscol Creek in the unincorporated Napa County, extends west across the Napa River, and terminates in the Highway 12 right-of-way near Stanley Lane in the city of Napa, California.

**Project Description:** The Project would authorize PG&E to replace three existing, 8-inch-diameter pipelines (L-021A, L-021 A-1, and L-021 A-2) with a new 26-inch-diameter pipeline under the Napa River during Phase 1. During Phase 2, PG&E would remove the existing pipelines under the Napa River (CSLC lease PRC 5438) and decommissioning in place the pipeline in the adjacent upland areas (outside of CSLC jurisdiction).
