### **QUITCLAIM DEED**

WHEREAS, pursuant to Chapter 1333, Statutes of 1968, as amended ("Burton Act"), and the implementing Agreement Relating to Transfer of the Port of San Francisco from the State of California to the City and County of San Francisco recorded on January 30, 1969, as Instrument No. R40413 in Book B 308, Page 686, of the Official Records of the City and County of San Francisco ("Transfer Agreement"), the State of California ("State") granted and conveyed to the City and County of San Francisco, a charter city and municipal corporation ("City"), all of the State's right, title, and interest in certain property within the City, subject to the public trust for navigation, commerce, and fisheries and the terms and conditions of the Burton Act and the Transfer Agreement (collectively, "Trust"), to be held and administered by the San Francisco Port Commission ("Port"); and

WHEREAS, the granted lands include "paper streets" known as Bancroft Avenue and Griffith Street and a portion of a former 200-foot-wide railroad right-of-way, which was not used and reverted to State ownership prior to transfer to the City (the "**Property**," as more particularly described **Exhibit A**); and

WHEREAS, pursuant to Chapter 211, Statutes of 2022 ("AB 2607"), the State authorized the State Lands Commission ("Commission") to accept any and all title and interest of the Port, as trustee pursuant to the Burton Act and Transfer Agreement, and thereafter to convey the Property to the City free from the Trust restrictions and obligations, subject to certain terms and conditions set forth in AB 2607; and

WHEREAS, the Port, by Port Resolution 22-19 adopted on April 12, 2022, agreed to transfer the Property subject to the terms and conditions set forth in AB 2607; and

WHEREAS, the City, acting by and through its Board of Supervisors, by Resolution No. 162-22 approved on April 19, 2022 and signed by the Mayor on April 28, 2022 approved the transfer of the Property and authorized the Port Executive Director and the San Francisco Director of Property to execute the transfer; and

WHEREAS, the Commission, at its public meeting on February 28, 2023, approved Staff Report No. **22**, found the transfer satisfied the terms and conditions set forth in AB 2607, and finally approved the transfer.

The STATE OF CALIFORNIA, acting by and through the STATE LANDS COMMISSION, does hereby REMISE, RELEASE AND FOREVER QUITCLAIM to the CITY AND COUNTY OF SAN FRANCISCO, all of the State's right, title, and interest in the Property as described in **Exhibit A**, subject to the reservation of all minerals and all mineral rights of every kind and character now known to exist or hereafter discovered, including, but not limited to, oil and gas and rights thereto, together with the sole, exclusive, and perpetual right to explore for, remove, and dispose of those minerals by any means or methods suitable to the state, its successors, or assignees, except that, notwithstanding the foregoing quitclaim or Section 6401 of the Public Resources Code, such reservation shall not include the right of the State or its successors or assignees in connection with any mineral exploration, removal, or disposal activity, to enter upon, use, or damage the surface of the lands or interfere with the use of the surface by the City or by the City's successors or assigns or conduct mining activities of any nature whatsoever above a plane located 500 feet below the surface of the lands without the prior written permission of the City or the City's successors or assigns.

The City shall use the property, together with adjacent lands, to construct and operate a fire training facility or a public facility addressing earthquake safety or emergency response for a minimum of 30 years.

This Patent is intended to and does terminate the Trust in the Property and the Property is hereby freed from the Trust.
