A quorum of Commissioners was present to celebrate the Piers 421 Last Shorezone Oil Production Piers Removed. Chair Kounalakis was joined by Commissioner Malia Cohen. While a quorum of Commissioners and their staff were present to attend an informational tour, no official action was taken at this part of the meeting. Under California state law, when a quorum of Commissioners is present for purposes related to the Commission's jurisdiction and authority it constitutes an official meeting and it must be properly noticed and open to the public.
