

PROPOSED ACTION:

Consider Acceptance of Retrocession of Partial Jurisdiction to Establish Concurrent Jurisdiction pursuant to California Government Code Section 113.

AREA, LAND TYPE, AND LOCATION:





Figure 2. Site Map

Federal land near San Onofre State Beach, within Camp Pendleton, San Diego County (as shown in Figure 1 and Figure 2).

BACKGROUND:

Legislative jurisdiction is the authority to make and enforce laws. The State ceded all or most of its legislative jurisdiction over some federal properties in the late 1800s and early 1900s. These cessions have the now-unwanted consequence of preventing State or local law enforcement from assisting with incidents on these properties, as well as limiting the rights of residents and workers. Consequently, the United States often seeks to retrocede some of its sole responsibility for the lands in question to establish a lesser degree of legislative jurisdiction, allowing the application of California laws and cooperation with State and local law enforcement agencies.

The United States acquired much of modern-day Camp Pendleton, including the lands at issue near San Onofre State Beach, by condemnation on December 31, 1942. California Political Code section 34 (<u>Ch. 710, Stats. of 1939</u>), the relevant jurisdictional statute at that time for condemnations for military purposes, offered all of the state's jurisdiction other than the powers to serve process and to tax. The United States accepted this offer and established its jurisdiction by letter dated September 8, 1943.

In the early 1970s, the U.S. Marine Corps and the California Department of Parks and Recreation negotiated a lease of federal lands to the state, which established San Onofre State Beach. The U.S. Marine Corps requested that the Commission accept a retrocession to establish concurrent legislative jurisdiction first over a 405-acre beach in 1971 (Item 10, October 28, 1971), as clarified and corrected by Item 55, June 28, 2007) and then over a larger area in 1973 (Item 18, November 29, 1973). These retrocessions were limited to the life of the lease, which expired on August 31, 2024.

Today, the Commission may accept retrocessions on behalf of the State pursuant to the express conditions of California Government Code section 113:

- A. The United States must in writing have requested state acceptance of the retrocession, and unless there is an officer of the United States empowered by a United States statute to retrocede jurisdiction, the request shall be by the act of Congress. The retrocession may return all jurisdiction to the state or may provide for concurrent jurisdiction.
- B. The proposed retrocession is in the best interest of the state.
- C. A notice of the proposed retrocession has been given to the clerk for the board of supervisors of each county in which the federal lands are located at least 15 days before the proposed retrocession is considered by the State Lands Commission.
- D. The United States has agreed to bear all costs and expenses incurred by the State Lands Commission in making the retrocession.
- E. The acceptance of the retrocession shall be made at a publicly noticed meeting of the State Lands Commission. The determination of the State Lands Commission shall be final and the retrocession of jurisdiction accepted shall become effective when certified copies of its orders or resolutions have been recorded in the office of the county recorder of each county in which any part of the land is situated. The State Lands

Commission shall keep copies of its orders or resolutions and make them available to the public upon request.

PROPOSED ACTION:

The U.S. Marine Corps and California Department of Parks and Recreation have negotiated a new lease for San Onofre State Beach. The U.S. Marine Corps has requested that the State of California accept a retrocession of jurisdiction over lands near San Onofre State Beach, more particularly described and shown as five separate parcels in Exhibit A. This includes the entire area to be leased to California Department of Parks and Recreation for the San Onofre State Beach and also areas adjacent to the lease premises that the public is likely to enter and access. The United States currently exercises partial legislative jurisdiction over these lands and seeks to establish concurrent jurisdiction. If accepted the retrocession would be indefinite.

STAFF ANALYSIS AND RECOMMENDATION:

AUTHORITY:

Government Code section 113.

STATE'S BEST INTERESTS:

The proposed retrocession would establish concurrent legislative jurisdiction over the lands described in Exhibit A, which are part of or adjacent to San Onofre State Beach. Accepting the retrocession would allow the state and the United States to share civil and criminal legislative jurisdiction. State agents, including California Park Rangers, Sheriff's staff, and local police, would be able to enforce State criminal law in the retroceded area. The United States would also retain its authority to enforce criminal laws on these lands, allowing federal, state, and local law enforcement authorities to work cooperatively.

The U.S. Marine Corps provided letters of support for the retrocession from California Department of Parks and Recreation, the federal Department of Justice, and the City of San Clemente. The Marine Corps also provided a copy of their Memorandum of Understanding with the Orange County Sheriff's Department, which establishes mutual support and cooperation between these agencies.

CONCLUSION:

For these reasons, staff believes that the retrocession of concurrent criminal legislative jurisdiction is in the best interest of the State. Further, staff believes that sufficient evidence exists to satisfy all requirements of Government Code section 113.

OTHER PERTINENT INFORMATION:

- Approval or denial of the retrocession is a discretionary action by the Commission. Each time the Commission approves or rejects a retrocession, it exercises legislatively delegated authority. If the Commission denies the requested retrocession, the state will continue to have only the powers to serve process and to tax within the area.
- 2. This action is consistent with the "Committing to Collaborative Leadership" Strategic Focus Area of the Commission's 2021-2025 Strategic Plan.
- 3. Commission staff provided notice of the proposed retrocession to the Clerk for the Board of Supervisors of San Diego County on September 18, 2024. The retrocession area lies wholly within San Diego County but abuts Orange County. Staff therefore provided courtesy notice to the Clerk for the Board of Supervisors of Orange County, though this is not required by statute.
- 4. The subject retrocession of jurisdiction is not a project as defined by the California Environmental Quality Act because it is an administrative action that will not result in direct or indirect physical changes in the environment.

Authority: Public Resources Code section 21065 and California Code of Regulations, title 14, sections 15060, subdivision (c)(3), and 15378, subdivision (b)(5).

RECOMMENDED ACTION:

It is recommended that the Commission:

AUTHORIZATION:

- 1. Find that the requirements of Government Code section 113 have been satisfied as follows:
 - a. The United States has requested state acceptance of the retrocession in writing by an authorized officer of the United States.
 - b. The retrocession will establish concurrent jurisdiction.
 - c. The retrocession is in the best interest of the state.
 - d. A notice of the retrocession has been given to the clerk for the board of supervisors of each county in which the federal lands are located at least 15 days before the proposed retrocession is considered by the State Lands Commission.
 - e. The United States has agreed to bear all costs and expenses incurred by the State Lands Commission in making the retrocession.
 - f. The acceptance of the retrocession is made at a publicly noticed meeting of the State Lands Commission.
- 2. Accept a retrocession of partial legislative jurisdiction and establish concurrent legislative jurisdiction over the lands described in Exhibit A.
- 3. Authorize the Executive Officer, or designee, to execute a Resolution of Retrocession of Legislative Jurisdiction for the purposes described herein and have it recorded in the official records of San Diego County.


