**GENERAL LEASE - PUBLIC AGENCY USE**

**APPLICANT:**

United States Department of the Interior  
Bureau of Reclamation  
P. O. Box D  
Yuma, Arizona 85364

**AREA, LAND TYPE, AND LOCATION:**

One acre, more or less, of sovereign land adjacent to the Colorado River, near Blythe, Riverside County.

**AUTHORIZED USE:**

Continued operation and maintenance of a rock and gravel stockpile site.

**LEASE TERM:**

Ten years, beginning November 30, 2000.

**CONSIDERATION:**

The public use and benefit; with the State reserving the right at any time to set a monetary rent if the Commission finds such action to be in the State's best interest.

**OTHER PERTINENT INFORMATION:**

1. Applicant has a right to use the uplands adjoining the lease premises.
2. In 1989, the California State Lands Commission (Commission) received fee title to the parcel of land, a portion of which is currently occupied by the stockpile site, pursuant to a boundary settlement with the upland owners (AD33).
3. The Applicant has stabilized various sections of the Lower Colorado River as part of the major river rectification projects authorized under the Colorado River Front Work and Levee System Act of 1927. In its continuing effort to maintain the existing bankline stabilization of the Colorado River, the Applicant has established various rock material stockpile sites at strategic locations along the Colorado River for the maintenance and repair of the existing levee system.

4. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities, Title 14, California Code of Regulations, section 15301.




