**ASSIGNMENT OF LEASE**

**LESSEE:**

Deugro International, Inc. dba Los Gatos Creek Ranch, Inc.

**ASSIGNEE:**

Walter Neubauer, as Trustee of Neubauer Family Trust dated May 19, 1993

**AREA, LAND TYPE, AND LOCATION:**

187.41 acres, more or less, of school lands near Coalinga, San Benito and Fresno counties.

**AUTHORIZED USE:**

Cattle grazing

**LEASE TERM:**

Ten years, beginning August 5, 1994.

**CONSIDERATION:**

\$500 per year; with the State reserving the right to fix a different rent periodically during the lease term, as provided in the lease.

**OTHER PERTINENT INFORMATION:**

1. Assignee owns the lands adjoining the lease premises.
2. The original lessee, Grant W. Squire, owned the Los Gatos Creek Ranch, from 1968 until 1979, at which time the property was sold to Walter Neubauer. Mr. Neubauer subsequently sold the property in 1984 and the grazing lease was assigned to Los Gatos Creek Ranch, Inc. The property

was subsequently sold back to the Neubauer Family Trust in 1996, and, thus, the need for the current assignment.

3. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA because the activity is not a "project" as defined by the CEQA and the State CEQA Guidelines.


