#### **GENERAL LEASE - RECREATIONAL USE**

#### APPLICANT:

Richard Buenting

#### AREA, LAND TYPE, AND LOCATION:

Sovereign land in Donner Lake, adjacent to 14246 South Shore Drive, near the town of Truckee, Nevada County.

#### **AUTHORIZED USE:**

Continued use and maintenance of an existing pier.

#### LEASE TERM:

10 years beginning February 1, 2015.

#### CONSIDERATION:

\$301 per year, with an annual Consumer Price Index adjustment.

#### SPECIFIC LEASE PROVISIONS:

Liability insurance in an amount no less than \$1,000,000 per occurrence.

#### OTHER PERTINENT INFORMATION:

- 1. Applicant owns the upland adjoining the lease premises.
- On February 17, 2005, the Commission authorized a Recreational Pier Lease to Richard Buenting. That lease expired on January 31, 2015. The Applicant is now applying for a General Lease – Recreational Use.
- 3. The staff recommends that the Commission find that this activity is exempt from the requirements of CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; California Code of Regulations, Title 2, section 2905, subdivision (a)(2).

#### SIGNIFICANT LANDS INVENTORY FINDING:

#### **AUTHORIZATION:**

Authorize issuance of a General Lease – Recreational Use to Richard Buenting beginning February 1, 2015, for a term of 10 years, for the continued use and maintenance of an existing pier as described in Exhibit A and shown on Exhibit B (for reference purposes only) attached and by this reference made a part hereof; annual rent in the amount of \$301, with an annual Consumer Price Index adjustment; and liability insurance with coverage in an amount no less than \$1,000,000 per occurrence.




