REVISION OF RENT

LESSEE:

Financial Portfolios, Ltd.

AREA, LAND TYPE, AND LOCATION:

Sovereign land in the Petaluma River, adjacent to 5683 Lakeville Road, near the city of Petaluma, Sonoma County.

AUTHORIZED USE:

Continued use and maintenance of an existing uncovered floating boat dock, pier, ramp, and two pilings.

LEASE TERM:

10 years, beginning April 27, 2010.

CONSIDERATION:

This lease provides that lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff reviewed the rent under this lease and recommends that rent be revised from \$101 per year to \$125 per year, effective April 27, 2017.

OTHER PERTINENT INFORMATION:

1. Lessee owns the upland adjoining the lease premises.
2. On April 27, 2010, the Commission authorized a General Lease – Recreational Use to Financial Portfolios, Ltd. for a term of 10 years beginning April 27, 2010 ([Calendar Item C13, August 14, 2012](#)). The lease will expire on April 26, 2020.
3. This action is consistent with Strategy 2.2 of the Commission's Strategic Plan to ensure timely receipt of revenues and royalties from the use and development of State lands and minerals.

4. Approving the revision of rent is not a project as defined by the California Environmental Quality Act because it is an administrative action that will not result in direct or indirect physical changes in the environment.

Authority: Public Resources Code section 21065 and California Code of Regulations, title 14, section 15378, subdivision (b)(5).




SITE
