
PROPOSED ACTION:

Revision of Rent.

AREA, LAND TYPE, AND LOCATION:


Figure 1. Location

Sovereign land in Mare Island Strait, adjacent to 19 Sandy Beach Road, near Vallejo, Solano County (as shown in Figure 1).

AUTHORIZED USE:

Continued use and maintenance of a portion of residence, deck, dock, and appurtenant facilities (as shown in Figure 2).

TERM:

30 years, beginning February 9, 2016.

CONSIDERATION:

The lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, the staff has conducted a review of the rent under this lease and recommends that the rent be revised from \$1,131 per year to \$2,644 per year, effective February 9, 2026.

OTHER PERTINENT INFORMATION:

- Approval or denial of the revision of rent is a discretionary action by the Commission. Each time the Commission approves or rejects a revision of rent, it exercises legislatively delegated authority and responsibility as trustee of the State's Public Lands as authorized by law. The Lessee has no right to a new lease or to renewal of any previous lease.
- 2. On February 9, 2016, the Commission authorized a 30-year General Lease Residential and Recreational Use (Item 56, February 9, 2016) to Katherine M. Walton, for the use and maintenance of a portion of residence, deck, pier, and appurtenant facilities in Mare Island Strait, adjacent to 19 Sandy Beach Road, near the city of Vallejo, Solano County. On April 5, 2016, the Commission authorized a correction to Lease 5782 (Item 30, April 5, 2016) to add a dock and correct the annual rent. The lease expires February 8, 2046.
- 3. This action is consistent with the "efficient and effective management of the revenue generation portfolio" elements in the "Meeting Evolving Public Trust Needs" Strategic Focus Area of the Commission's 2021-25 Strategic Plan.
- 4. Approving the revision of rent is not a project as defined by the California Environmental Quality Act because it is an administrative action that will not result in direct or indirect physical changes in the environment.
 - Authority: Public Resources Code section 21065 and California Code of Regulations, title 14, sections 15060, subdivision (c)(3), and 15378, subdivision (b)(5).
