Dear Governor Brown:

There is inclosed a copy of Easement No. DA-04-167-ENG-3905 dated 9 February 1966 and granted by the United States to the State of California for a right-of-way for public roads across a portion of Oakland Army Base. The Secretary of the Army accepted exclusive Federal jurisdiction over the easement area in an application dated 5 July 1950 to the State Lands Commission, which determined on 5 October 1950 that the application met requirements of Section 126 of the Government Code of California. It is desired to relinquish concurrent jurisdiction to the State of California over this road easement area in order that it may exercise law enforcement thereover.

Therefore, notice is hereby given, in accordance with provisions of Public Law 87-852 approved 23 October 1962 (76 Stat. 1129; 40 United States Code 319) and as provided in the easement grant, that the United States relinquishes and retrocedes to the State of California concurrent legislative jurisdiction over the area of the inclosed easement, effective upon acceptance thereof or by proceeding in such manner as the laws of California may provide (particularly Section 77 of the Government Code, or any other applicable laws). I shall appreciate your advising me when this relinquishment of jurisdiction has been duly accepted and also acknowledging receipt of this notice on the duplicate copy hereof and returning it to this office.

Dear Mr. Resor:

On September 6, 1966, you sent a letter to the former Governor, The Honorable Edmund G. Brown, concerning the transfer of an easement No. DA-04-167-ENG-3905, dated 9 February 1966. This easement granted to the State of California a right-of-way upon the lands of the United States situated in the City of Oakland, County of Alameda, State of California.

This letter is in response to the United States offer to relinquish jurisdiction set forth in your September 6, 1966 letter as follows:

"Therefore, notice is hereby given, in accordance with provisions of Public Law 87-852 approved 23 October 1962 (76 Stat. 1129; 40 United States Code 319) and as provided in the easement grant, that the United States relinquishes and retrocedes to the State of California concurrent legislative jurisdiction over the area of the inclosed easement, effective upon acceptance thereof or by proceeding in such manner as the laws of California may provide (particularly Section 77 of the Government Code, or any other applicable laws)."

I am pleased to inform you that the State of California desires to accept the offer; now therefore,

I, Ronald Reagan, Governor of the State of California, by virtue of the power vested in me by section 77.5 of the California Streets and Highways Code enacted in 1967
