DA-04-167-five-3690, executed on the 12th day of april 1967, by Sherry 3 . Myers, Chief, Real Property Division, UASA (I \& L).

Military Reservation Presidio of Monterey, Honterey County, Caiifornia, and the Southwesterly line of Lighthouse Avenue said point of intersection being distant S. $89^{\circ} 30^{\circ}$. W. 732.92 feet from a stone monum ment at the Northeasterly corner of said U. S. Military Reservation and running thence the following courses:
(1) N. $89^{\circ} 30^{\prime}$ E., 194.24 feet along the North line of the Presidio of Monterey to its intersection vith the Noxtheasterly line of Lighthouse Avemue;
(2) S. $62^{\circ} 26^{\circ}$ E., 238.96 feet along the IFortheasterly line of Lighthouse Avenue to its intersection with the Northwesterly line of Foam Street;
