Dear Mr. Froehlke:

Thank you for your letter requesting that the State of California accept retrocession of jurisdiction of approximately 2.53 acres of land acquired from the United States by the City of Pacifica by an easement dated March 29, 1971. The land is located at the Milagra Ridge Military Reservation, San Mateo County, and was acquired by the City of Pacifica for the improvement of Sharp Park Road.

The City of Pacifica has accepted the deed in accordance with our Streets and Highways Code, and, therefore, I, Ronald Reagan, Governor of the State of California, by virtue of the power vested in me by Section 77.5 of the Streets and Highways Code, hereby accept retrocession of exclusive jurisdiction by the United States to the State of California over the area described in the enclosed document, No. DACA05-2-71-50, executed on the 29th day of March 1971, by Sherry B. Myers, Assistant for Real Property, OASA (I & L).
