41. CESSION OF CONCURRENT JURISDICTION AND RETROCESSION OF JURISDICTION OVER THE METROPOLITAN CORRECTION CENTER, SAN DIEGO COUNTY - W 20958, W 20942.

After consideration of Calendar Item 41 attached, and upon motion duly made and carried, the following resolution was approved by a vote of 2-0:

THE COMMISSION:

1. RESOLVES THAT THE STATE OF CALIFORNIA, ACTING BY AND THROUGH THE STATE LANDS COMMISSION, PURSUANT TO CALIFORNIA GOVERNMENT CODE SECTION 126, CONSENTS TO THE ACQUISITION AND GRANTS A CESSION OF CONCURRENT JURISDICTION OVER THE METROPOLITAN CORRECTION CENTER, SAN DIEGO COUNTY, AND THE U. S. NAVAL FACILITY, TERMINAL ISLAND, LOS ANGELES COUNTY.
2. RESOLVES THAT THE STATE OF CALIFORNIA, ACTING BY AND THROUGH THE STATE LANDS COMMISSION, PURSUANT TO CALIFORNIA GOVERNMENT CODE SECTION 113, CONSENTS TO THE RETROCESSION OF CONCURRENT JURISDICTION OF THE U. S. NAVAL FACILITY, TERMINAL ISLAND, LOS ANGELES COUNTY.
3. FINDS THAT ALL THE PROVISIONS OF CALIFORNIA GOVERNMENT CODE SECTIONS 126 AND 113 HAVE BEEN COMPLIED WITH AND THAT IT IS WITHIN THE BEST INTERESTS OF THE STATE TO GRANT THESE CESSIONS OF CONCURRENT JURISDICTION AND ACCEPT THE RETROCESSION OF CONCURRENT JURISDICTION COVERING THE METROPOLITAN CORRECTION CENTER, SAN DIEGO COUNTY, AND THE U. S. NAVAL FACILITY, TERMINAL ISLAND, LOS ANGELES COUNTY.
4. DECLARES THAT THIS ACTION IS CONFIRMATORY OF THE ACTIONS OF THE STATE LANDS COMMISSION TAKEN ON CALENDAR ITEM NO. 10 (MINUTE ITEM NO. 10, DATED JANUARY 15, 1976) OF ITS JANUARY 15, 1976, MEETING AND CALENDAR ITEM NO. 24 (MINUTE ITEM NO. 24, DATED MARCH 25, 1976) AT ITS MARCH 25, 1976, MEETING AS CLARIFIED ABOVE.

CESSION OF CONCURRENT JURISDICTION

At its meeting of January 15, 1976, the State Lands Commission considered and approved Calendar Item No. 10 regarding the cession of concurrent jurisdiction to the United States over the Metropolitan Correction Center in San Diego County. The State Lands Commission granted this cession of concurrent jurisdiction pursuant to the provisions of California Government Code Section 126. The Commission found that all the requirements of California Government Code Section 126 were complied with and that all the reservations contained therein were retained to the State.

At its regular meeting of March 25, 1976, the State Lands Commission considered and approved Calendar Item No. 24 granting a cession of concurrent jurisdiction and accepting a retrocession of concurrent jurisdiction over the United States Naval Facility, Terminal Island, Los Angeles County. This action was taken pursuant to California Government Code Sections 126 and 113. The Commission found that all the requirements of both Sections 126 and 113 were complied with and that all the reservations contained therein were retained to the State.

It has come to the attention of the staff in regard to the above mentioned items that certain technical corrections should be made in order to further clarify and to insure that there is no possible ambiguity regarding the previous action of the Commission. This Calendar Item will make those corrections and confirm the action of the Commission at its prior meetings concerning the cession of concurrent jurisdiction to the United States over the Metropolitan Correction Center, San Diego County, and the U. S. Naval Facility, Terminal Island, Los Angeles County. This also confirms the action of the Commission as to the acceptance of a retrocession of concurrent jurisdiction over the U. S. Naval Facility, Terminal Island, Los Angeles County.

IT IS RECOMMENDED THAT THE COMMISSION:
