AD. 1980 Pursuant to Government Code, Section 126, the State Lands Commission is authorized on behalf of the State to cede concurrent criminal jurisdiction to the United States upon finding:

- The land is held for the erection of forts, arsenals and other needful buildings within the purview of clause 17, of Section 8, of Article 1 of the Constitution of the United States:
- The cession is in compliance with the laws of the United States:
- The United States has in writing requested such cession; and
- The State reserves jurisdiction over the land, for purposes of water acquisition and management.

By letter dated December 14, 1979, the United States Navy requested a cession of concurrent criminal jurisdiction over Moffett Homes-Orion Park, Moffett Naval Air Station, Santa Clara County, California. The parcel in question comprises approximately 83.92 acres. Calendar Item 44, June 1980, authorized Commission staff to conduct a public hearing pursuant to Government Code, Section 126. The hearing was held on November 24, 1980. No comments regarding the cession were received at the hearing.

The staff believes that therefore, cession of concurrent criminal jurisdiction is in the best interest of the State of California in connection with the administration of police power over the area.

JURISDICTION AND THAT THE FOLLOWING CONDITIONS HAVE BEEN SATISFIED:

- A. THE UNITED STATES HAS REQUESTED IN WRITING THAT THE STATE OF CALIFORNIA CEDE CONCURRENT CRIMINAL JURISDICTION OVER THE LAND DESCRIBED IN EXHIBIT "B" ATTACHED AND BY REFERENCE MADE A PART HEREOF, SAID LANDS BEING WITHIN THE STATE OF CALIFORNIA.
- B. THE LAND IS HELD BY THE UNITED STATES FOR THE ERECTION OF FORTS, MAGAZINES, ARSENSALS, DOCKYARDS, AND OTHER NEEDFUL BUILDINGS WITHIN THE PURVIEW OF CLAUSE 17, OF SECTION 8 OF ARTICLE 1 OF THE CONSTITUTION OF THE UNITED STATES.
- C. THE LAND IS HELD BY THE UNITED STATES IN FEE BY PURCHASE.
- D. JURISDICTION CEDED PURSUANT TO GOVERNMENT CODE, SECTION 126, CONTINUES ONLY SO LONG AS THE LAND IS HELD BY THE UNITED STATES FOR THE ABOVE-DESCRIBED PURPOSES OR FOR FIVE YEARS, WHICHEVER PERIOD IS LESS.
- E. IN CEDING SUCH CONCURRENT CRIMINAL JURISDICTION
  THE LEGISLATURE AND THE STATE RESERVE JURISDICTION
  OVER THE LAND, WATER AND USE OF WATER WITH FULL
  POWER OF CONTROL AND REGULATE THE ACQUISITION,
  USE, CONTROL AND DISTRIBUTION OF WATER WITH RESPECT
  TO THE LAND AFFECTED BY SUCH CESSION.
- F. IN CEDING CONCURRENT CRIMINAL JURISDICTION THE LEGISLATURE AND THE STATE EXCEPT AND RESERVE TO THE STATE ALL DEPOSITS OF MINERALS, INCLUDING OIL AND GAS, IN THE LAND, AND TO THE STATE, OR PERSONS AUTHORIZED BY THE STATE, THE RIGHT TO PROSPECT FOR, MINE, AND REMOVE SUCH DEPOSITS FROM THE LAND.
- 2. DETERMINE THAT A CESSION OF CONCURRENT CRIMINAL JURISDICTION OVER THE LAND DESCRIBED IN EXHIBIT "B" ATTACHED AND BY REFERENCE MADE A PART HEREOF IS IN THE BEST INTERESTS OF THE STATE OF CALIFORNIA.
- 3. CEDE THE REQUESTED CONCURRENT CRIMINAL JURISDICTION OVER MOFFETT HOMES-ORION PARK, MOFFETT NAVAL AIR STATION, SANTA CLARA COUNTY, CALIFORNIA. SAID CESSION TO BE EFFECTIVE UPON APPROVAL OF THIS CALENDAR ITEM BY THE COMMISSION AND THE RECORDATION OF ALL NECESSARY DOCUMENTS.
