RESOLUTION OF RETROCESSION OF LEGISLATIVE JURISDICTION

California Government Code Section 113

WHEREAS the United States acting by and through the Department of the Navy has requested that the State of California accept a retrocession of partial legislative jurisdiction and establish concurrent legislative jurisdiction over a portion of the lands comprising the Naval Construction Battalion Center, Port Hueneme, Ventura County more specifically described in Exhibit A hereto ; and

WHEREAS the California State Lands Commission, pursuant to California Government Code Section 113, has been authorized by the California State Legislature to accept such a retrocession of jurisdiction; and

WHEREAS the Executive Officer of the State Lands Commission has been authorized by its Commissioners to execute this instrument;

NOW, THEREFORE, I, Paul D. Thayer, Executive Officer of the California State Lands Commission hereby certify that the Commissioners for the California State Lands Commission met on April 7, 2003 and accepted a retrocession of partial legislative jurisdiction from the United States and established concurrent jurisdiction over the lands described in Exhibit A hereto. A copy of the Commission's Agenda Item No. C 34 describing the terms and conditions of the retrocession is attached hereto as Exhibit B.

LAND DESCRIPTION NAVAL BATTALION CONSTRUCTION CENTER, VENTURA COUNTY

That portion of Subdivision 87 of Rancho El Dio De Santa Clara O'La Colonia (6 Deeds 161) more particularly described as follows:

RETROCESSION OF JURISDICTION OVER A PORTION OF THE NAVAL CONSTRUCTION BATTALION CENTER, PORT HUENEME, VENTURA COUNTY

PARTY:

United States of America
Department of the Navy

BACKGROUND:

The United States exercises partial jurisdiction over the Naval Construction Battalion Center, Port Hueneme, Ventura County. By letter dated October 9, 2002, the Department of the Navy requested that California accept a retrocession of partial jurisdiction over forty-two one hundredths acres of this facility and to establish concurrent legislative jurisdiction. The subject parcel is outside of the perimeter fence of the Base and will be used for sidewalks and road improvements. The Navy and the City believe that the combined police forces of the Navy and the City will provide the best security for children and other persons using the parcel.

California Government Code Section 113 authorizes the State Lands Commission to accept such a retrocession if the following conditions are met:

1. The United States has in writing requested that the State accept a retrocession of jurisdiction;
2. The State Lands Commission has held a public hearing to determine whether it is in the State's best interests to accept the retrocession; and
3. The United States has agreed to pay for the costs associated with the retrocession process.

The United States has made the written request for the retrocession and has agreed to bear the costs associated with the retrocession. The Navy has provided the Commission with a letter indicating that the police department for the City of Port

Hueneme has no objection to the retrocession and establishment of concurrent jurisdiction. The noticed hearing was held on March 25, 2003. No comments in opposition to the retrocession were received. Commission staff believes the requested action is in the best interests of the State and recommends that the United States' request be granted.

IT IS RECOMMENDED THAT THE COMMISSION:

2. FIND THAT THE U.S. DEPARTMENT OF THE NAVY HAS REQUESTED THAT THE COMMISSION ACCEPT A RETROCESSION OF PARTIAL JURISDICTION AND ESTABLISH CONCURRENT JURISDICTION OVER A PORTION OF THE NAVAL CONSTRUCTION BATTALION CENTER, PORT HUENEME, VENTURA COUNTY AS DESCRIBED IN EXHIBIT A TO THIS CALENDAR ITEM.
3. FIND THAT THE UNITED STATES HAS AGREED TO PAY FOR THE COSTS OF THE RETROCESSION PROCESS.
3. FIND THAT THE STATUTORY PUBLIC HEARING WAS HELD AS REQUIRED.
4. DETERMINE THAT IT IS IN THE BEST INTERESTS OF THE STATE OF CALIFORNIA TO ACCEPT THE RETROCESSION OF PARTIAL JURISDICTION AND TO ESTABLISH CONCURRENT JURISDICTION AS REQUESTED BY THE UNITED STATES BECAUSE SUCH A JURISDICTIONAL

ADJUSTMENT WILL ALLOW STATE AND LOCAL LAW ENFORCEMENT SERVICES TO BE MADE AVAILABLE TO PERSONS USING THE PROPERTY SUBJECT TO THE RETROCESSION.

5. ACCEPT THE RETROCESSION OF PARTIAL JURISDICTION OVER A PORTION OF THE NAVAL CONSTRUCTION BATTALION CENTER, PORT HUENEME, VENTURA COUNTY AS DESCRIBED IN EXHIBIT A TO THIS CALENDAR ITEM AND ESTABLISH CONCURRENT JURISDICTION OVER THOSE SAME LANDS.
6. AUTHORIZE THE EXECUTIVE OFFICER TO EXECUTE A CERTIFICATE OF RETROCESSION DESCRIBING THE COMMISSION'S ACTION AND RECORD IT IN THE COUNTY OF VENTURA AS REQUIRED BY GOVERNMENT CODE SECTION 113.
