RESOLUTION OF
RETROCESSION TO CONCURRENT CRIMINAL LEGISLATIVE JURISDICTION

California Government Code Section 113

WHEREAS the United States acting by and through the Department of the Army has requested that the State of California accept a retrocession to establish concurrent criminal legislative jurisdiction over lands within the Marine Ocean Terminal Concord in Contra Costa County, more specifically described in Exhibit A hereto; and

WHEREAS the California State Lands Commission, pursuant to California Government Code Section 113, has been authorized by the State Legislature to accept retrocessions of legislative jurisdiction; and

WHEREAS the United States, acting by and through the Department of the Army, by letter submitted June 16, 2018, requested that the State accept a retrocession to establish concurrent criminal legislative jurisdiction;

NOW, THEREFORE, I, Jennifer Lucchesi, Executive Officer of the California State Lands Commission hereby certify that the Commissioners for the California State Lands Commission met on August 23, 2018 and accepted a retrocession to establish concurrent criminal legislative jurisdiction over lands within the Marine Ocean Terminal Concord in Contra Costa County. A copy of the Commission's Agenda Item No. C106 describing the terms and conditions of the Commission's action is attached hereto as Exhibit A.

CONSIDER A CESSION OF CONCURRENT CRIMINAL LEGISLATIVE JURISDICTION PURSUANT TO GOVERNMENT CODE SECTION 126 AND AN ACCEPTANCE OF RETROCESSION OF PARTIAL LEGISLATIVE JURISDICTION PURSUANT TO GOVERNMENT CODE SECTION 113 OVER LANDS AT THE MARINE OCEAN TERMINAL CONCORD, CONTRA COSTA COUNTY

PARTY:

United States, Department of the Army

AREA, LAND, TYPE, AND LOCATION:

The Marine Ocean Terminal Concord, Contra Costa County.

BACKGROUND:

The United States owns lands at the Marine Ocean Terminal Concord in Contra Costa County. These lands historically were operated as part of the Naval Weapons Station Concord and Port Chicago. The United States presently has partial legislative jurisdiction over some of these lands and proprietary jurisdiction over other lands. It desires to have uniform concurrent criminal legislative jurisdiction over all these lands for ease of administration of enforcement of criminal law with State and local law enforcement authorities. Establishment of uniform concurrent criminal legislative jurisdiction will require a cession of concurrent criminal law over lands now held under proprietary jurisdiction and the acceptance of a retrocession of partial legislative jurisdiction, establishing concurrent criminal legislative jurisdiction over the lands subject to the retrocession.

CESSION:

Pursuant to Government Code section 126, the Commission is authorized, on behalf of the State of California, to cede concurrent criminal legislative jurisdiction to the United States upon finding:

- A. The United States has requested such a cession in writing.
- B. The federal lands are held for the erection of forts, magazines, arsenals, dockyards and other needful buildings within the purview of clause 17, section 8, article I of the United States Constitution or other federal purpose.

- C. The cession is made pursuant to and in compliance with the laws of the United States.
- D. A notice of the proposed cession has been given to the clerk for the board of supervisors of the county in which the federal lands are located at least 15 days before the proposed cession.
- E. The proposed cession is in the best interests of the State of California.
- F. The United States has agreed to bear all costs and expenses incurred by the Commission in making the cession.

Upon making these findings and the Commission having made a cession, the State and the United States will equally share the State's criminal legislative jurisdiction over lands affected by the cession, described in Exhibit A. The cession shall continue only so long as the lands are owned by the United States and used for the purposes for which jurisdiction is ceded or for 10 years, whichever period is less. In ceding concurrent criminal legislative jurisdiction, the State reserves its full civil legislative jurisdiction including its jurisdiction over the land, water, and use of water with full power to control and regulate the acquisition, use, control, and distribution of water with respect to the land affected by the cession.

By letter signed by Paul D. Cramer, Deputy Assistant Secretary of the Army, submitted June 16, 2018, the United States has requested that the State cede concurrent criminal legislative jurisdiction over the lands described in Exhibit A for a 10-year period for military purposes.

These lands comprise a portion of the Marine Ocean Terminal Concord in Contra Costa County and are all owned by the United States.

A notice of the proposed cession was sent to the Clerk of the Board of Supervisors for Contra Costa County on July 24, 2018.

The United States has agreed to bear all costs and expenses incurred by the Commission in making the cession.

Staff believes all pertinent federal law has been complied with and the United States has indicated in its June 16, 2018 submission that its acceptance of the cession, as required by 40 U.S.C. section 3112, will be effective upon the

Commission having made the requested cession and recording it in the official records of Contra Costa County.

RETROCESSION:

Pursuant to Government Code section 113, the State consents to retrocessions of legislative jurisdiction by the United States subject to the following conditions:

- A. The United States, acting by and through Congress or a statutorily authorized official, has requested in writing that the State accept a retrocession.
- B. The proposed retrocession is in the best interests of the State of California.
- C. A notice of the proposed retrocession has been given to the clerk for the board of supervisors of each county in which the federal lands are located at least 15 days before the proposed retrocession is considered by the Commission.
- D. The United States has agreed to bear all costs and expenses incurred by the Commission in making the retrocession.
- E. The acceptance of the retrocession shall be made at a publicly noticed meeting of the Commission. The determination of the Commission shall be final, and the retrocession of jurisdiction accepted shall become effective when certified copies of its orders or resolutions have been recorded in the office of the county recorder of each county in which any part of the land is situated.

Acceptance of a retrocession is permanent, subject only to subsequent cessions or retrocessions.

By letter signed by Paul D. Cramer, Deputy Assistant Secretary of the Army (Installations, Housing, and Partnerships), submitted June 16, 2018, the United States has requested that the State accept a retrocession of partial legislative jurisdiction over lands described in Exhibit B, which are a part of the Marine Ocean Terminal Concord and to permanently establish concurrent criminal jurisdiction over them. Authority to retrocede legislative jurisdiction is granted to the Secretary of the Army by 10 U.S.C. section 2683, and it is exercised by the

Deputy Assistant Secretary of the Army (Installations, Housing, and Partnerships) pursuant to a delegation by General Order 2017-01 (January 5, 2017).

A notice of the proposed retrocession was sent to the Clerk of the Board of Supervisors for Contra Costa County on July 24, 2018.

The United States has agreed to bear all costs and expenses incurred by the Commission in making the retrocession.

STAFF ANALYSIS AND RECOMMENDATION:

Authority:

Government Code sections 126 and 113.

State's Best Interests Analysis:

Ceding concurrent criminal legislative jurisdiction over lands described in Exhibit A and comprising a portion of the Marine Ocean Terminal Concord to the United States would allow the United States to share the State's authority enforce state criminal law over those lands. Accordingly, the United States could independently enforce criminal law for crimes committed on these lands instead of relying on local law enforcement to respond and enforce the law. Thus, the proposed cession would alleviate the burden on local law enforcement agencies while preserving their authority to enforce the law for crimes committed at Marine Ocean Terminal Concord, if needed. For these reasons, staff believes that the cession of concurrent criminal legislative jurisdiction is in the best interests of the State.

Accepting a retrocession of partial legislative jurisdiction and establishing concurrent criminal legislative jurisdiction over the lands described in Exhibit B and comprising a portion of the Marine Ocean Terminal Concord will restore the State's civil legislative jurisdiction over these lands and share the State's criminal legislative jurisdiction with the United States. Consequently, the State's civil and criminal laws will apply to these lands, and local law enforcement will be able to enforce State criminal law on them. Also, because the retrocession would establish concurrent criminal legislative jurisdiction, the United States will also have authority to enforce state criminal laws on these lands, allowing the federal, state, and local law enforcement authorities to work cooperatively. For these reasons, staff believes that the retrocession of concurrent criminal legislative jurisdiction is in the best interests of the State.

OTHER PERTINENT INFORMATION:

1. This action is consistent with Strategy 3.1 of the Commission's Strategic Plan to "foster, improve, and enhance relationships, to engage the legislature, public, local, state and federal agencies, legislative grantees, Commission lessees, potential applicants, non-governmental organizations, and the regulated community."
2. Staff recommends that the Commission find that the subject cession of jurisdiction and acceptance of the subject retrocession of jurisdiction do not have a potential for resulting in either a direct or a reasonably foreseeable indirect physical changes in the environment, and are, therefore, not projects in accordance with the California Environmental Quality Act (CEQA).

Authority: Public Resources Code section 21065 and California Code of Regulations, title 14, sections 15060, subdivision (c)(3), and 15378.

RECOMMENDED ACTION:

It is recommended that the Commission:

CEQA FINDING:

Find that the subject cession of jurisdiction and acceptance of the subject retrocession of jurisdiction are not subject to the requirements of CEQA pursuant to California Code of Regulations, title 14, section 15060, subdivision (c)(3) because the subject activities are not projects as defined by Public Resources Code section 21065 and California Code of Regulations, title 14, section 15378.

AUTHORIZATION:

1. Find that the following requirements of Government Code section 126 have been satisfied:
 - A. The United States has requested in writing that the State cede concurrent criminal legislative jurisdiction over the lands described in Exhibit A attached and by reference made a part hereof, said lands being within Contra Costa County, State of California.

- B. The lands are held by the United States for the erection of forts, magazines, arsenals, dockyards, and other needful buildings within the purview of clause 17 of section 8 of article I of the Constitution of the United States, or for another federal purpose.
 - C. The cession is made pursuant to and in compliance with the laws of the United States.
 - D. A notice of the proposed cession has been given to the clerk for the board of supervisors of Contra Costa County, in which the federal lands are located, at least 15 days before the proposed cession.
 - E. The proposed cession is in the best interests of the State.
 - F. The United States has agreed to compensate the State of California for its cost incurred in processing the cession.
- 2. Cede concurrent criminal legislative jurisdiction to the United States over the lands described in Exhibit A for so long as the lands are owned by the United States and used for military purposes or for 10 years, whichever period is less.
 - 3. Authorize the Executive Officer or her designee to execute a Resolution of Cession of Concurrent Criminal Legislative Jurisdiction and have it recorded in the Official Records of Contra Costa County.
 - 4. Find that the following conditions of Government Code section 113 have been met:
 - A. The United States, acting by and through Congress or a statutorily authorized official, has requested in writing that the State accept a retrocession of partial legislative jurisdiction and establish concurrent criminal jurisdiction over the lands described in Exhibit B attached and by reference made a part hereof, said lands being within Contra Costa County, State of California.
 - B. The proposed retrocession and establishment of concurrent criminal legislative jurisdiction is in the best interests of the State.

- C. A notice of the proposed retrocession has been given to the clerk for the board of supervisors of each county in which the federal lands are located at least 15 days before the proposed retrocession is considered by the Commission.
- D. The United States has agreed to bear all costs and expenses incurred by the Commission in making the retrocession.
- 5. Accept a retrocession of partial legislative jurisdiction over the lands described in Exhibit B and permanently establish concurrent criminal legislative jurisdiction over them.
- 6. Authorize the Executive Officer or her designee to execute a Resolution of Retrocession of Legislative Jurisdiction and have it recorded in the Official Records of Contra Costa County.
