CHAPTER 527.

An act relating to the acquisition of land, water or land and water within the State of California by the United States for migratory bird reservations.

[Approved by the Governor May 28, 1929. In effect August 14, 1929]

The people of the State of California do enact as follows:

SECTION 1. The people of the State of California, through Acceptance of federal their legislative authority, do hereby accept the provisions and "Migratory bird" benefits of that certain act of congress known as the "Migra-conservation" tory bird conservation act," approved February 18, 1929, and act." do hereby consent to the acquisition by the United States by purchase, lease, gift or devise of such areas of land, water or land and water, within the State of California, as the United States or its properly constituted officers or agents may deem necessary for migratory bird reservations in carrying out the provisions of said act of congress; saving and reserving, however, to the State of California such full and complete jurisdiction and authority over all such areas as are not incompatible with the administration, maintenance, protection and control thereof by the United States under the terms of said act of congress, and saving and reserving to all persons within such areas all rights, privileges and immunities under the laws of the State of California in so far as the same are compatible with the administration, maintenance, protection and control of such areas by the United States under the terms of said act of congress.

SEC. 2. The people of the State of California, through their Consent to legislative authority, do hereby further consent to the declara- ment of tion, withdrawal or determination of any part of any national reservation forest or power site as a migratory bird reservation under any of the provisions of said act of congress.

SEC. 3. The director of the department of natural resources Director of is hereby authorized and empowered to be and become a member ex officio of the migratory bird conservation commission created by said act of congress.

CHAPTER 528.
