CHAPTER 307

An act to add a new section to Chapter 6 of Division 4 of the Agricultural Code, to be numbered 721.5, relating to proceedings to enjoin violation of certain provisions thereof.

The people of the State of California do enact as follows:

SECTION 1. A new section is hereby added to Chapter 6 of Division 4 of the Agricultural Code, to be numbered 721.5, to read as follows:

New section

721.5. The director may bring an action to enjoin the violation or threatened violation of any provision of Chapter 1 to Chapter 6, both inclusive, of Division 4 of this code, in the superior court in and for the county in which the violation occurred or is about to occur. Any proceeding under the provisions of this section shall conform to the requirements of Chapter 3 of Title 7 of Part 2 of the Code of Civil Procedure, except that the director shall not be required to allege facts necessary to show or tending to show lack of adequate remedy at law or to show or tending to show irreparable damage or loss.

CHAPTER 308

An act transferring to the United States of America an easement over certain lands of the State of California for lighthouse purposes.

The people of the State of California do enact as follows:

SECTION 1. An easement for lighthouse purposes is hereby transferred to the United States of America over those certain filled tidelands in Ventura County, California, adjacent to and seaward of the United States Coast Guard Reservation on which is located the Point Hueneme Lighthouse and which filled tidelands occupy an area with boundaries as follows:

Lighthouse

On the north, that portion of the ordinary high water mark of the Pacific Ocean coincident with the south boundary of the said United States Coast Guard Reservation; on the south, the day-to-day line of ordinary high water mark of the Pacific Ocean; on the west, a line bearing due south which passes through the most westerly point of the above described north boundary; and on the east, a line bearing due south which passes through the most easterly point of the above described north boundary.

Boundaries

Jurisdiction The United States of America shall have jurisdiction over the hereinbefore described real property, subject to the right of the State to have concurrent jurisdiction so far that all processes, civil or criminal, issued under authority of the State may be executed by the proper officials thereof upon the hereinbefore described real property, upon any person or persons amenable to the same, in like manner and with like effect as if this transfer had not been made. This easement shall terminate whenever the United States of America shall discontinue the maintenance of a lighthouse upon the real property now owned by the United States of America contiguous to the hereinbefore described real property.

The people of the State of California do enact as follows:

Stats 1939, SECTION 1. Section 12710 of the Business and Professions
p. 2771 Code is hereby amended to read as follows:

True net weight, etc 12710. When any commodity is sold subject to public weighmaster weights, such weights shall be the true net weight. Net weight is the correct or actual weight of the commodity excluding the weight of the container or conveyance. Actual weight shall mean the weight obtained from one draft of vehicle loads. In determining the net weight of any commodity, the entire weight of the vehicle and load must rest on the scale at one time. Until December 31, 1943, double draft (two-spot) weights may be recorded on "State certificate of weights and measures" provided the words "two-spot" or "double draft" are stamped thereon, and when so stamped shall not be construed a violation of Section 12706 of this code.
