(b) Any territory any point of which touches any point of the district.

(c) Any territory separated from the district by a "separating barrier," which term includes a street, road, highway, railway line, railway crossing, railway right of way, water course, lagoon, or other natural barrier.

Any territory specified in this section may consist of one or more separate parcels of land, but it is not necessary that all parcels shall constitute in the aggregate one tract of land.

CHAPTER 226

An act accepting a retrocession of jurisdiction from the United States of America over certain rights of way granted to the State of California over a certain road in the Presidio of San Francisco Military Reservation.

SECTION 1. The State of California hereby accepts that certain retrocession of jurisdiction granted by the United States of America over certain rights of way for a State road known as Funston Avenue Approach across the Presidio of San Francisco Military Reservation by an act of the Congress of the United States entitled "An act to grant to the State of California a retrocession of jurisdiction over certain rights-of-way granted to the State of California over a certain road about to be constructed in the Presidio of San Francisco Military Reservation," approved July 26, 1939.

CHAPTER 227

An act to repeal an act entitled "An act making an appropriation to be expended by and under the direction of the Department of Public Works for the purpose of rectifying, improving and protecting the channel of the Pajaro River," approved May 28, 1929, and to abolish the Pajaro River Flood Control Fund, which is created thereby.

The people of the State of California do enact as follows:

Repeal

SECTION 1. The act cited in the title hereof is hereby repealed.

SEC. 2. The Pajaro River Flood Control Fund in the State Treasury is hereby abolished and any money remaining in that fund on the effective date of this act shall revert to and become a part of the General Fund.
